Public Comments:

Barbara Toles extended wishes for everyone a healthy happy New Year. She encouraged that everyone stays away from unmasked, un-vaccinated people.

Barbara Toles also announced that her sorority Sigma Gamma Rho, in honor of their centennial anniversary would be giving out 25 \$10k scholarships to high school seniors. She reported that all scholarship applications must be in by March 2022.

Nikki Purvis noted scholarship opportunities with her sorority Zeta Phi Beta. She said the local chapter would be extending scholarship opportunities and that she would forward a copy of the application.

Donna Brown-Martin extended Happy New Year wishes to the commission as well. She noted that these are exciting times both politically and socially in Milwaukee County. She said that SDC was in the right place at the right time.

Board Chair Report:

Commission Chairman Elmer Moore Jr. welcomed Jennifer Harris, SDC Public Policy and research Manager. He reported that Mrs. Harris would be spearheading the work on the Institute on Poverty & Systemic Racism.

Mrs. Harris thanked the Chairman and echoed her personal excitement.

Chairman, Moore Jr. also expressed his excitement about the new leadership heading the Social Development Foundation. Alicia Smith-McCants.

Chairman, Moore Jr. made the observation that we are moving into the 3rd year of the covid-19 pandemic. SDC's capacity to serve has more than doubled. He said that he is proud of the work SDC is doing and is equally excited about what's to come.

CEO Report:

SDC CEO, Dr. George P. Hinton reported the following:

- Jennifer Harris would be working on the work identified in the strategic planning process daily.
- SDC is awaiting next MERA allocation
- The Lead Abatement Program is awaiting the contract that would allow collaboration between SDC, Employ Milwaukee and The Absolute Advantage Program. This is an opportunity to help expand the labor force through job training.

- SDC is very close to receiving an answer from HUD regarding its Home Buyer counseling program.
- SDC is also preparing to launch the 2022 VITA season January 31st.
- SDC continues to form partnerships around vaccination opportunities and covid-19 education.

Marketing:

Marketing Specialist, Chantell Sain reported the following:

- Pathways Podcast: Recent Feature on Financial Education & Budgeting occurred. Guest was SDC Financial Counselor, Warwees Holt.
- Youthology Youth Podcast happens monthly
- There will be a series of 5 podcast to occur and will go live on the cr-sdc.org website.
- The Youth Counsel is discussing a potential Spring Youth Run
- Mrs. Sain shared a Mission Moment Video

Dr. Hinton acknowledged Commissioner John Jacobs as a star Commission member for helping out with connections. He reported that one program participant was hired into the trades.

Financial Report:

SDC Direction of Finance, Patrick Kirsenlohr reviewed July income statements.

Finance Committee Chair, Terese Caro asked if SDC was tracking to stay on budget for the projected outcomes. Patrick Kirsenlohr responded, yes.

Dr. Hinton said while finance is behind they are still working toward the audit as scheduled. He appealed to the commission for recommendations & references for accounting department staffing needs.
